ORDER:

UPON the Plea bargain Agreement dated 20<sup>th</sup> day of October, 2017 and filed on the same day by – Ajobiwe Rotimi Enitan for EFCC praying the court for the following:

1. It is proposed that the defendant shall:
  - a) Serve a prison sentence of (1) one year commencing from the date of his arrest, and
  - b) Pay a fine as may be prescribed by this honourable court.
2. The defendant should be of good conduct and abstain from any form of criminal activity especially those connected to the internet.
3. That the defendant shall forfeit 70% of the entire sum in his ECO Bank Ltd. account number 3012028612 to the Federal Government of Nigeria by raising a manager's cheque in the name of the Cash Assets under Final Forfeiture Sub, and
4. An order of this honorable court defreezing the defendant's ECO Bank account number - 2323000285 and 3012028612.

AND AFTER HEARING the submission of Mike Enendu for the accused and Ajobiwe Rotimi Enitan for the prosecution,

THE COURT HEREBY ORDERED AS FOLLOWS:

1. That the accused shall serve a prison sentence of (1) one year commencing from the date of his arrest,
2. That the accused shall in addition pay fine of N100,00.00.
3. The accused should be of good conduct and abstain from any form of criminal activity especially those connected to the internet.
4. That the accused shall forfeit 70% of the entire sum in his ECO Bank Ltd. account number 3012028612 to the Federal Government of Nigeria by raising a manager's cheque in the name of the Cash Assets under Final Forfeiture Sub, and
5. That the ECO Bank account number 2323000285 and 3012028612 belonging to the accused is hereby ordered to be defrozen.

Issued at Enugu under the Seal of Court and Hand of the Presiding Judge, this 27<sup>th</sup> day of November, 2017.

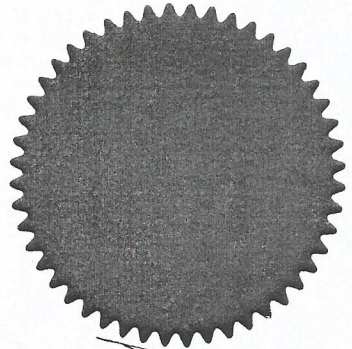
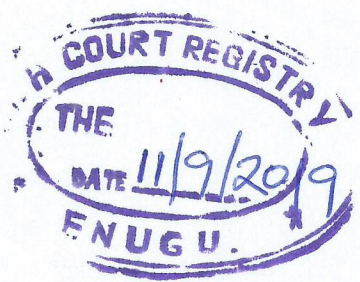
