The sum of \$45, 100 that was found on him at the Airport enroute to Dubai was creditors money and in error he declared only \$45,000 and forgot to declare the \$100 that was in his wallet that was how he ended up with EFCC and eventually charged before this court.

In the course of the investigation by EFCC and the testimony of witness in court they acknowledged that he is a genuine business man. Since this incidence his foreign partners have been putting pressure on him they are beginning to form the opinion that he is one of those Nigerians who dupe foreigners. In that circumstance, we decided that we should apply to EFCC for plea bargain. Under Section 270 of the Administration of Criminal J ustice Act 2015. EFCC reviewed his case and agreed with us, that this is a case that fall within the said section 270. We have reduced our agreement into writing and filed it in this court it is dated 12th March, 2016 both parties have signed it.

We are pleading with the court to tamper justice with mercy and allow us to adopt this agreement as our agreement and ask the court to sentence the Accused in line with the terms of the Application I hereby adopt the agreement.
