**THIS PLEA BARGAIN AGREEMENT PURSUANT TO
SECTION 270 OF THE ADMINISTRATION OF CRIMINAL
JUSTICE ACT, 2015 THIS 5TH DAY OF DECEMBER, 2019.**

WHEREAS:

- 1) The Defendant is charged before this Honourable Court for fraudulently presenting himself as **BENJAMIN EMMANUEL FORKE**, an American citizen using an email address to wit: benjamineforke@gmail.com and in that assumed identity obtained the sum of One hundred and ninety thousand naira (₦190,000.00) only from one Elizabeth, a Spanish citizen, an offence contrary to Section 22(3) (b) and punishable under Section 22(4) of the Cybercrimes (Prohibition, Prevention) Act 2015.

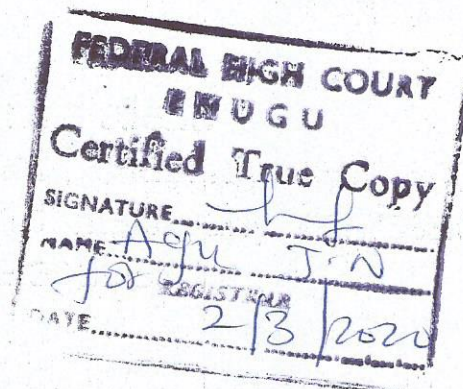


- 2) The Defendant has shown great remorse for his actions and has paid back the sum of \$300 (Three Hundred United Dollars) which he fraudulently obtained from one Elizabeth, a Spanish citizen (the victim of his crime) as restitution to her through the Economic and Financial Crimes Commission and has promised not to engage in cyber crime again.
- 3) The Defendant has further approached the prosecution to enter a plea bargain and the prosecution hereby accepts as stated hereunder;


NOW IT IS HEREBY AGREED AS FOLLOWS:


- 1) That before the conclusion of this agreement, the Defendant was informed;
 - i) That he has a right to remain silent.
 - ii) Of the consequences of not remaining silent; and
 - iii) That he is not obliged to make any confession that could be used in evidence against him.
- 2) That the Defendant shall plead guilty to the amended charge dated 5th day of December, 2019
- 3) That upon conviction, a prison term of three (3) months from the date of his arrest and detention by the Economic and Financial Crimes Commission on the 24th day of October, 2019, is hereby proposed.
