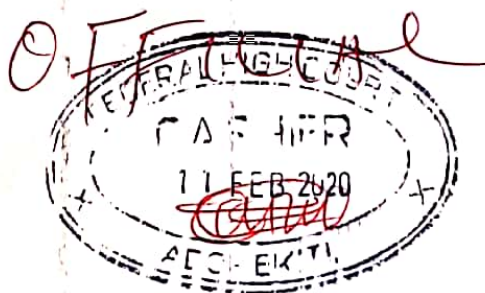
AMENDED CHARGE

**PLEA BARGAIN AGREEMENT PURSUANT TO SECTION 270(4) OF  
THE ADMINISTRATION OF CRIMINAL JUSTICE ACT, 2015**

**THIS PLEA BARGAIN AGREEMENT** made this 10<sup>th</sup> day of February, 2020 Between the **Federal Republic of Nigeria** (Prosecution) of the one part and **BLESSING JEJELWO** (Defendant) of the other part.

**WHEREAS** the prosecution has filed a Four counts charge of knowingly having in possession documents containing false pretence contrary to Section 1(2) (a) and punishable under 1 (2) of the Advance Fee Fraud and Other Fraud Related Offences Act, 2006 against the defendant, the Defendant has approached the prosecution to plea bargain the aforesaid charge and sentence.

**WHEREAS** the defendant has offered to forfeit and has indeed forfeited through the Federal Republic of Nigeria his **iPhone 7 Plus, One Small Nokia** and **\$800 (Eight Hundred United States of American Dollars)**, to the Federal Government of Nigeria, being medium upon which he communicates with his victim which offer the prosecution accepts.

**WHEHEAS** before the conclusion of this agreement, the defendant was informed as follows:

- a. That he has the right to remain silent
- b. Of the consequences of not remaining silent, and
- c. That he is not obliged to make any confession or admission that could be used in evidence against him.

**WHEREAS** the Defendant in the course of investigation voluntarily confessed to having in his possession documents containing false pretense in his gmail account chemistry220@gmail.com and sending same through a computer system and network to his victims.

**NOW IT IS HEREBY AGREED AS FOLLOWS:**

1. That the Defendant has agreed to forfeit and has indeed forfeited through the Federal Republic of Nigeria his **iPhone 7 Plus, One Small Nokia and \$800 (Eight Hundred United States of American Dollars)** to the Federal Government of Nigeria, being medium upon which he communicates with his victim.
2. That the Four counts charge filed against the defendant should be amended to one count charge of impersonation contrary to Section 22(2) (b) (i) of Cybercrimes (Prohibition, Prevention etc.) Act, 2015 and punishable under Section 22(3) of the same Act.
3. That the Defendant shall plead guilty to the amended Charge.
4. That the Honourable Court considers a custodial sentence of 10 (Ten) months with effect from the date of arrest being 10<sup>th</sup> of July, 2019 in line with the provision Section 270 (11) of the Administration of Criminal Justice Act 2015.
