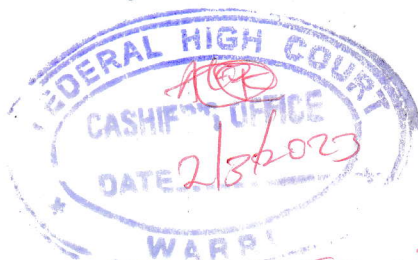

The charge was read and explained to the Defendant in English Language by the Court's Registrar and he pleaded guilty. The matter was then adjourned to 13/12/2021 for the review of the facts of the case and the Defendant subsequently remanded in Correctional Centre Sapele pending review of the facts of the case.

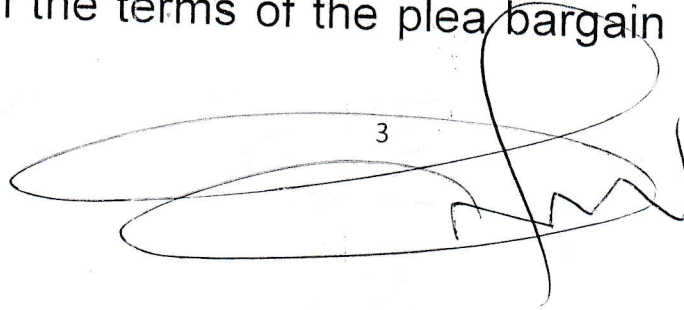

The court did not sit on 13/12/2021. The court was on official assignment at Abuja. The matter was then adjourned to 5/5/2022 for review of the facts of the case.

On 5/5/2022 instead of reviewing the facts of the case, the prosecution counsel Mr. F. O. Dibang informed the court of a Plea Bargain Agreement dated 18/10/2021 executed between the prosecution and the Defendant. Learned counsel for the prosecution then informed the court that he will be relying on the Plea Bargain Agreement dated 18/10/2021 and signed by the parties, also witnessed by their respective counsel. Learned counsel for the Defendant Prince P. E. Uwadel had no objection.

The court in response and in line with the provisions of section 270 subsection 10 of ACJA directed the Court's Registrar to read the charge over to the Defendant and also explain the terms of the plea bargain agreement and

enquire from the Defendant whether he stands by the term of the Plea bargain. This exercise was successfully carried by the Court's Registrar.

The Defendant still pleaded guilty to the one court charge dated 6/4/2021 and also informed the court that he voluntarily signed the Plea Bargain Agreement without being compelled to do so by anybody. Learned counsel representing the parties then urged the court to make the Plea Bargain Agreement the Judgment of the court and convict the Defendant accordingly. It was then about 4:10 pm on 5/5/2022. There was no light in the court room. The court room was dark and the court could not see clearly to discharge its functions. The court did not want to call for candle to aid its vision in the court room. The court had to rise and adjourned Judgment in the matter to avoid people of unsound mind making it an issue that the court sat

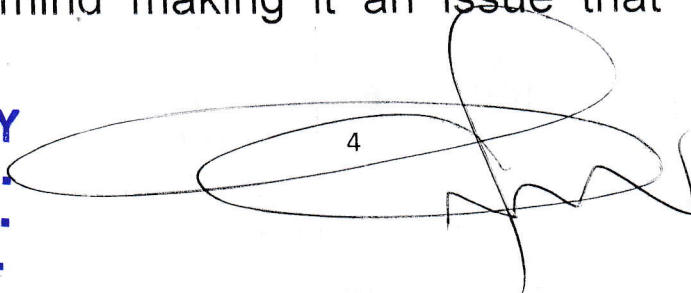

beyond 4pm. The matter was then adjourned to 27/6/2022 for Judgment. The court was indisposed on 27/6/2022 and Judgment was not delivered. The matter was again adjourned to 4/7/2022 for Judgment. However the Court's Registrar failed to forward the case file to the court in chambers a week before 4/7/2022 to prepare the said reserved Judgment. The court was surprised seeing the matter fixed for Judgment on the cause list of 4/7/2022. The court blamed its Registrars for this negligence and then adjourned the matter further still today for Judgment. Under section 270 of Acja both parties in criminal trial can compromise their rights and enter Plea bargain agreement that will be made the

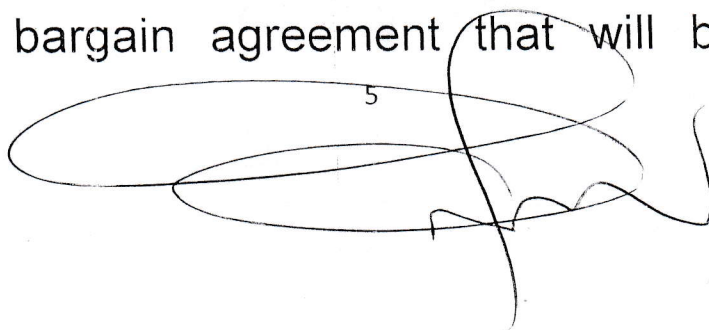

Judgment of the court. In this regard the parties entered and signed Plea bargain agreement dated 18/10/2021. It was signed by the Defendant and prosecution counsel and witnessed by the Defendant's counsel Bridget Eghosa Ambrose (Mrs).

In line with the Plea bargain agreement dated 18/10/2022 and signed by the parties, the Defendant is hereby convicted of the one count charge dated 6/4/2033.

The convict is hereby sentenced to 5 years imprisonment with effect from today or pay **Five Hundred Thousand Naira (N500,000.00)** to Federal Government of Nigeria.

The convict's Mobile Phone Iphone 7 with **IMEI No. 355835081130163** and one **Common 15 Air Techno** with **IME No. 355207111945911** recovered from him during investigation and linked to the crime is hereby forfeited to Federal Government. These items shall be

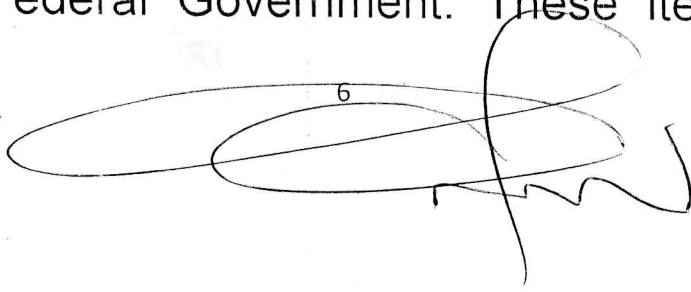

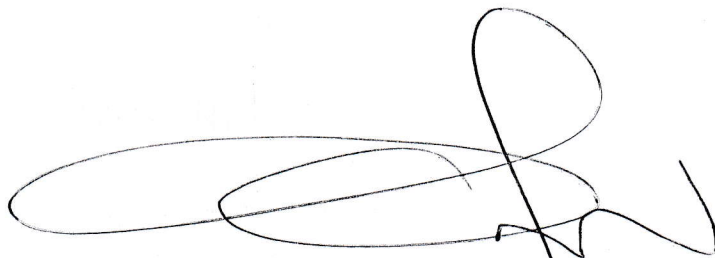
