UPON THIS AMENDED CHARGE dated 3rd February, 2022 but filed on 9th February, 2022.

Count 1

That you BLESSED OSARETIN (M) sometime between 2019 and 12th September, 2021 in Edo State within the jurisdiction of this Honourable Court did fraudulently impersonate the identity of NOAH HARRY with the intent to obtain money and thereby committed an offence contrary to Section 22(2)(b)(ii) of the Cybercrime (Prohibition Prevention etc.) Act, 2015 and punishable under Section 22(2) (b)(iv) of the same Act.

The Defendant having pleaded GUILTY to the Charge.

AND AFTER HEARING *Francis A. Jirbo Esq* with *I.K. Agwal Esq* for the prosecution applying that the Plea Bargain Agreement dated 3rd February, 2022 but filed on 9th February, 2022 be made the Judgment of the Court.

AND *Peter Igbino* *Esq* for the Defendant not opposing.

IT IS HEREBY ORDERED AS FOLLOWS:

1. Defendant is found **GUILTY** as Charged.
2. He is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correctional Service (NCS) with option of ₦500,000.00 (Five Hundred Thousand Naira) fine, Sentence shall commence from today and fine shall be paid into the account in which fines levied by this Court are paid.
3. Orders of forfeiture, non-foreclosure and undertaking to be of good behavior are made in accordance with the terms stated at paragraphs 3, 4, 5, and 6 of the Plea Bargain Agreement dated 3rd February, 2022 but filed on 7th February, 2022, to wit:

PLAINTIFF

(a) The Convict shall forfeit the balance in his Guaranty Trust Bank Account Number: 062905278 as proceeds of Crime to the Federal Government of Nigeria through the Economic and Financial Crimes Commission (EFCC).

(b) The convict shall forfeit 1. One iphone 11 with IMEI Number: 356548103473466/356548103439111.
2. One iphone 6 with IMEI Number: 359482082158376 recovered from him as instrumentalities of the crime with which he is convicted to the Federal Government of Nigeria through the Economic and Financial Crimes Commission (EFCC).

(c) This conviction and forfeiture of the above listed assets and properties shall not operate as a foreclosure against the commission (EFCC) from applying to the Court for forfeiture of any other assets/property(ies) subsequently traced to the Convict as proceeds of crime with
