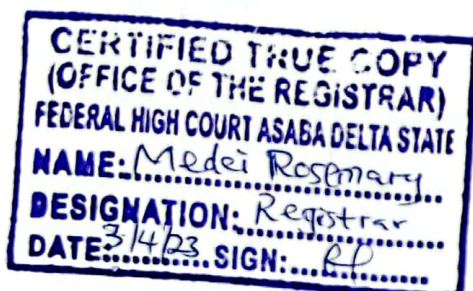

JUDGMENT

On 1<sup>st</sup> November, 2021, the Defendant pleaded guilty to the essential elements of the Amended Charge dated 25<sup>th</sup> October, 2021 in which she stands charged for the offence of impersonating another person living or dead with intent to gain advantage for herself.

The Prosecution presented the facts of the case through PW1 and Exhibits P1 to P14. The Court was thereafter urged to convict the

Defendant and sentence her in line with the plea bargain agreement.

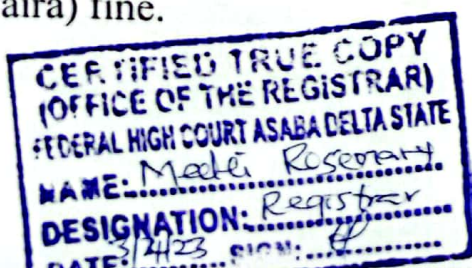
My task at this stage is to determine whether or not the Prosecution has proved its case. Having carefully considered the evidence before the Court through the testimony of PW1 and **Exhibits P1 to P14**, this Court finds the Defendant guilty as charged.

Defence Counsel: **Allocutus:**

Defendant has pleaded guilty. Court should temper justice with mercy. She is a student, she is still young, and can help to build Nigeria. She was having fun on social media without knowing the implication. She is writing examinations.

### **SENTENCE**

The convict and the prosecution having entered into a plea bargain agreement filed on 29<sup>th</sup> October, 2021, the convict is sentenced to 3 years imprisonment in the custody of the Nigeria Correctional Service with option of ₦200,000.00 (Two Hundred Thousand Naira) fine.

She shall forfeit the infinix Hot 8 phone as well as the contents of GTB Account No: 0461422239 and Zenith Bank Account No: 2388960280 to the Federal Government through the Economic and Financial Crimes Commission (EFCC).

In the event that the need arises to do so in future, the Economic and Financial Crimes Commission (EFCC) may apply to Court for the forfeiture of any other assets traced to the Convict as proceeds of the crime stated in the charge dated 25<sup>th</sup> October, 2021.

The fine shall be paid into the account in which fines levied by this Court are paid.



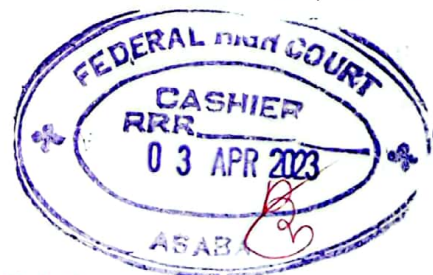
