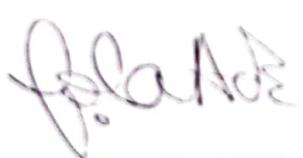

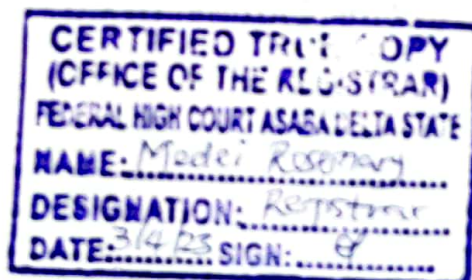
UPON THIS AMENDED CHARGE dated 25th
October, 2021 but filed on 29th October, 2021.

Charge

That you WISDOM OGHARADORO (alias Mary, JEFF HANDRICK, WENDY BINARY and JERRY WILLIAMS) on or about 23rd of March, 2021, within the jurisdiction of this Honourable Court, did impersonate the identity of one MARY HARRY, JEFF HANDRICK and JERRY WILLIAMS by sending fraudulent/scammed mails and pictures on hangout through the internet which documents you claim emanated from them with the intent to gain advantage of yourself and thereby committed an offence contrary to Section 22(2)(b)(1) of the Cybercrimes (Prohibition Prevention etc) Act, 2015, and punishable under Section 22(2)(b)(iv) of the same Act.

IT IS HEREBY ORDERED AS FOLLOWS:

1. That Convict is sentenced in accordance with the plea bargain agreement dated 25th October, 2021 but filed on 29th October, 2021 as follows:
 - a. A term of 3 (Three) years imprisonment in the custody of the Nigerian Correctional Service with option of ₦200,000.00 (Two Hundred Thousand Naira) fine payable into the account in which fines levied by this Court are paid.
 - b. That it is further ordered that convict shall forfeit his Black I phone 12 and contents of his Access Bank Account No: 1404195273 to Federal Government through the Economic and Financial Crimes Commission (EFCC).
 - c. That in the event that the need arises to do so in future, the Economic and Financial Crimes Commission (EFCC) may apply to the Court for the forfeiture of any other assets traced to the Convict as proceeds of the crime stated in the charge dated 25th October, 2021.
 - d. That the fine shall be paid into the account in which fines levied by this Court are paid.
