DEFENDANT COUNSEL:


We are ready.

Charge read to the defendant in English language, the charge was explained to the defendant.

Defendant understands the charge read and pleads as follows: Defendant pleads guilty to the charge

PROSECUTING COUNSEL: We urge your lordship to convict the defendant based on his plea. It is hinged on a plea bargain agreement dated 14th




We refer to section 270 subsection 9 and 10 and 352 (2) of the Administration of Criminal Justice Act, 2015 and urge the court to convict the defendant based on his plea.

**DEFENDANT COUNSEL:** 

When I was briefed of this matter, I called the defendant's counsel who is also a law enforcement officer and informed him of the option available and if they are willing to proceed on trial or follow a plea bargain, they took the option of the plea bargain and we informed the prosecution. The plea bargain agreement was then drawn up which was signed by all parties, we urge the Honourable Court to give effect to the plea bargain agreement.

COURT:

I am satisfied that the defendant has pleaded guilty to the essential elements of the offense charged stated in the charge dated 14th January, 2022 and do hereby found him guilty as charged. The plea bargain agreement dated 14th January, 2022 and filed on 26th January, 2022 is hereby made the judgement of this court. Convict is sentenced to 5 years in the custody of the Nigeria Correctional service with the option of 500,000 fine. Sentence shall commence from today and fine shall be paid into the accounts in which fines levied by this court are paid. This court also makes orders of forfeiture, non-foreclosure and undertaken to be of good behavior as contained at paragraph 3, 4, 5 and 6 of the plea bargain agreement dated 14th January, 2022 and filed on 26th January, 2022
