Count 1

That you OYEWUMI AKINTADE (A.K.A SHAROV) sometime January, 2016 at Ondo State, within the jurisdiction of this Honourable Court did fraudulently impersonate the identity of one Sharov Walter Freedman a (White man) with intent to gain advantage for yourself and thereby committed an offence contrary Section 22(2)(b)(i) and (ii) of the Cybercrime (Prohibition, Prevention, ETC) Act, 2015 and punishable under Section 22(2)(iv) of the same Act

The Defendant having pleaded GUILTY to the Charge.

AND AFTER HEARING Francis A. Jirbo Esq with I.K. Agwai Esq for the prosecution applying that the Plea Bargain Agreement dated 14th January, 2022 but filed on 26th January, 2022 be made the Judgment of the Court.

AND T.E. Osazuwa Esq for the Defendant not opposing.

IT IS HEREBY ORDERED AS FOLLOWS:

- Defendant is found GUILTY as Charged.
- 2. The Plea Bargain Agreement dated 14th January 2022 filed 26th January, 2022 is hereby made the Judgment of this Court. Convict is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correctional Service (NCS) or shall pay 14300,000.00 (Three Hundred Thousanc Naira) fine, Sentence shall commence from today and fine shall be paid into the account in which fines levied by this Court are paid.
- 3. This Court also makes Orders of forfeiture, nonforeclosure and undertaking to be of good behavior are made in accordance with the terms stated at paragraphs 3, 4 and 5 of the Plea Bargain Agreement dated 14th January, 2022, to wit:
 - a. The Convict shall forfeit to the Federal Government of Nigeria one Infinix 54 with IMEI Number 35370097766 as instrumentality of crime recovered in the course of investigation through the Economic and Financial Crimes Commission (EFCC).
 - b. The Convict shall undertake to be of good behavior and will never involve in committing internet fraud or any offences again.
 - c. It is agreed that nothing in this agreement shall preclude the prosecution from proceeding to attach and forfeit to the Federal Government of Nigeria any property that may be traced to the Defendant as having purchased with proceeds of the crime with which he is herein convicted.
