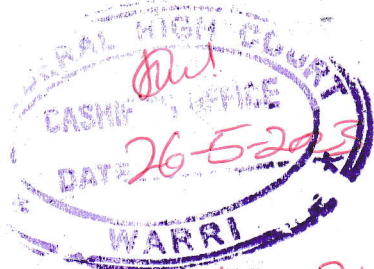

**JUDGMENT ORDER**

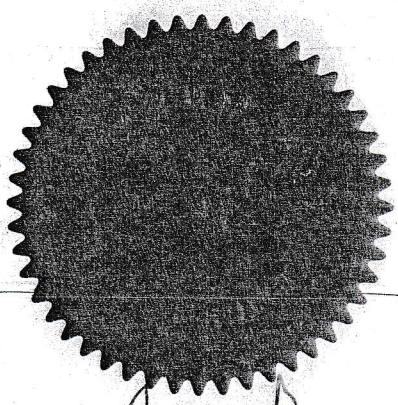
Upon this Criminal charge coming up for plea this 19<sup>th</sup> day of March, 2020, the defendant pleaded guilty to the 2(two) count charges and the prosecution called one(1) witness and tendered Exhibits A-I<sup>(1-2)</sup>. The Court having delivered its Judgment.

**IT IS HEREBY ORDERED AS FOLLOWS:**

1. *That* the convict is sentenced to prison term of 5 years commencing from the date of Judgment being 19/3/2020 or an option of fine of N6,000,000.00 (Six million Naira) only on Count 1.
2. *That* the convict is sentenced to prison term of 5 years commencing from the date of Judgment being 19/3/2020 or an option of fine of N6,000,000.00 (Six million Naira) only on Count 2.

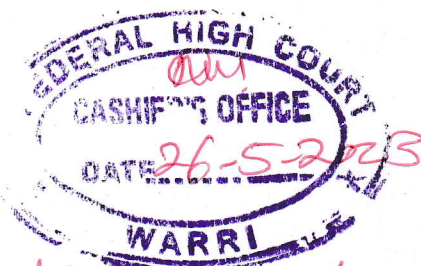
3. *The* sentence shall run concurrently.
4. *That* the properties recovered from the convict being proceeds of crime be forfeited to the Federal Government of Nigeria and released proceeds sent to the victims of the crime through the Economic & Financial Crime Commission (E.F.C.C.).

*The properties are as follows:*

- (i) Range Rover Sport Jeep Car;
  - (ii) The Filling Station located at Udu, Delta State;
  - (iii) Uncompleted Plaza, located at Udu, Delta State; and
  - (iv) Three Mobile Phones.
5. *The* Convict shall undertake in writing to be of good behavior and Law abiding.
