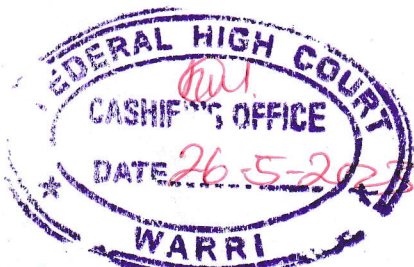



The Defendant is hereby convicted as charged pursuant to Plea Bargain Agreement signed by the parties dated 3rd February, 2023 see section 270 (1 & 2) of Acja and 274 (2) of Acja.

(1) In line with the Plea bargain agreement dated 3/2/2023 the convict Omoghan Destiny Igbinosa is





hereby sentenced to two years imprisonment with effect from today the 17/2/2023 or pay a fine of **One Million Naira (₦1,000,000.00)**.

- (2) **The \$2,235,000.** US Dollars recovered from the convict as proceeds of crime are hereby forfeited to Federal Government of Nigeria through Economic and Financial Crimes Commission (EFCC).
- (3) The convict shall forfeit his mobile Iphone 12 Pro-Max with IMEI No. 357061222383813 and Iphone 7 with IMEI No. 355310086154444 used in perpetrating the crime to the Federal Government of Nigeria through Economic and Financial Crimes Commission (EFCC).
- (4) Again nothing in this Judgment shall preclude the prosecution from proceedings to attach and forfeit to the Federal Government of Nigeria any property



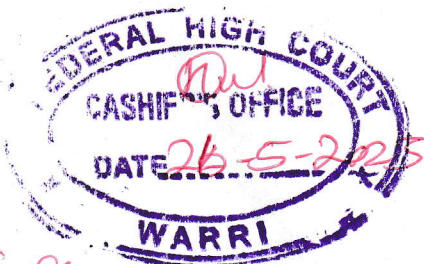
