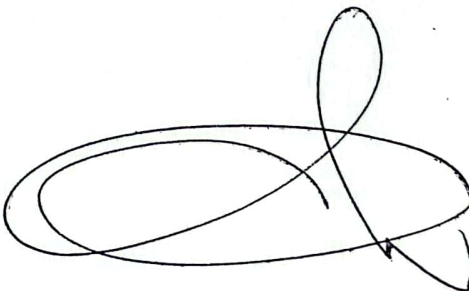

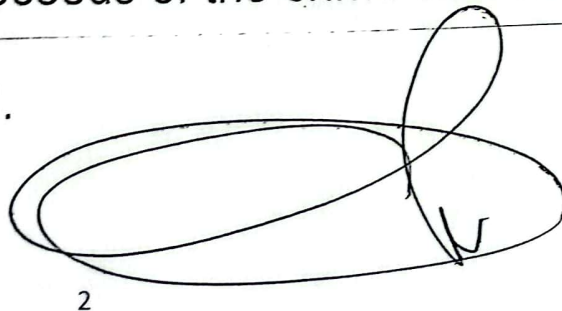

- (2) The convict shall forfeit his Iphone 7 plus mobile phone with IMEI No. 35537508079711 used in perpetrating the crime to the Federal Government of Nigeria.
- (3) Nothing in this Judgment shall preclude the prosecution from proceeding to attach and forfeit to the Federal Government of Nigeria any property that may be traced to the convict as having been purchased with proceeds of the crime with which he is herein convicted.

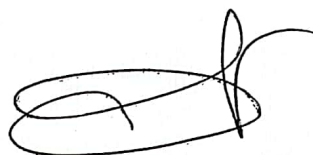

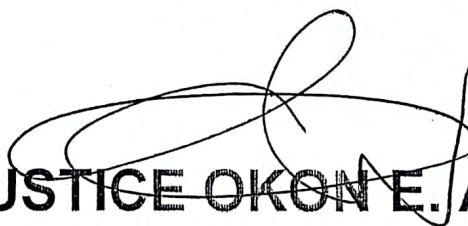
