
UPON THIS CHARGE dated 27th October, 2021 but filed on 28th October, 2021.

That you OHUMUMWEN OSAARIEMEN (M) sometimes between January and 12th September 2021 at Benin City, Edo State within the jurisdiction of this Honourable Court with intent to defraud, sent electronic message which materially misrepresent your identity to the duo of NICKII BABEE and TAINA BANDZ, American ladies upon which they relied and suffered financial loss in the sum ₩10,000,000.00 (Ten Million Naira) thereby committed an offence contrary to and Section 14(2) of punishable under Cybercrime (Prohibition Prevention etc.) Act 2015.

The Defendant having pleaded GUILTY to the Charge.

AND AFTER HEARING *Francis .A. Jirbo Esq* with **K.Y. Bello Esq** for the prosecution applying that the Plea Bargain Agreement dated 27th October 2021

IT IS HEREBY ORDERED AS FOLLOWS:

- 1. The Defendant is found **GUILTY** as Charged. He is sentenced to a period of 5 (Five) Years Imprisonment in the custody of the Nigerian Correction Service (NCS) commencing from today or in the alternative shall pay a fine of N1M (One Million Naira), said fine shall be paid into the account in which fines levied by this Honourable Court shall be paid.
- 2. It is further ordered that the Convict shall forfeit the balance in the bank accounts stated at paragraph 3 and 5 of the Plea Bargain Agreement and the properties listed at paragraph 4 thereof to the Federal Government of Nigeria through the Economic and Financial Crimes Commission (EFCC); to wit:
 - (a) Zenith Bank, Account Number: 2269954944
 - (b) Access Bank, Account Number: 1418374390
 - (c) One iphone Pro Max with IMEI Number 35466121009292/354506121443350
 - (d)On iphone 11 Pro Max with IMEI Number 356566104430988/356566104336961
 - (e) One unregistered black Lexus ES 350 2014 Model with Chassis No. JIHBKIGG1F2178751
- 3. Also, this conviction and forfeiture shall not operate as a foreclose against the Economic and Financial Crimes Commission (EFCC) from applying to the Court for forfeiture of other assets or properties not herein mentioned which may subsequently be traced to the convict as

4. That Convict shall make an undertaking in writing to be of good behavior and to desist from criminal activities.
