IT IS HEREBY ORDERED AS FOLLOWS:

- 1. Defendant is accordingly found **GUILTY** as Charged. He is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correction Service (NCS) with option of N500,000.00 (Five Hundred Thousand Naira) fine payable into the account which fines levied by this Court are paid.
- 2. The Convict shall forfeit the sum of money in the Bank account stated at paragraph 3 of the Plea Bargain Agreement and shall forfeit the items listed at paragraph 4 thereof; to wit:
 - (a) United Bank for Africa, Account Number: 2130887131
 - (b) One iphone 6 Plus with IMEI 359248066948177
 - (c) One Tecno Spark 5 Pro with IMEI Number: 35518114056481/355158114056499
 - 3. Paragraphs 5 and 6 of the Plea Bargain Agreement are also made the Judgment of this Court.
