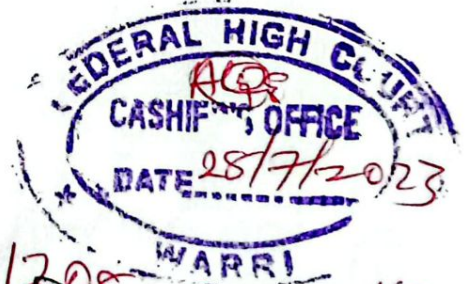
I hereby convict the Defendant Ohien Joy accordingly.




## SENTENCE

The convict shall within 24 hours undertake in writing to be of good behaviour and desist from such Criminal Acts.


