COUNT 1

That you, **IBRAHIM ALIYU**, in your capacity as Deputy Planning Director of the Bauchi State Ministry of Land and Survey, **SALISU WADA**, in your capacity as a Staff of the Bauchi State Ministry of Land and Survey and **JUMMAI YARO** in your capacity as a Staff of Bauchi State Agricultural Development Programme (BSADP), and in such capacities, sometime in 2019 at Bauchi, Bauchi State within the Jurisdiction of this Honourable Court, did conspire among yourselves to commit an offence to wit: obtain money by false pretence contrary to the provision of **Section 96 of the Penal Code Law** and punishable under **Section 97 of the same Law**.

COUNT 2

That you, **IBRAHIM ALIYU**, in your capacity as Deputy Planning Director of the Bauchi State Ministry of Land and Survey, **SALISU WADA**, in your capacity as a Staff of the Bauchi State Ministry of Land and Survey and **JUMMAI YARO** in your capacity as a Staff of Bauchi State Agricultural Development Programme (BSADP), and in such capacities, sometime in 2019 at Bauchi, Bauchi State within the Jurisdiction of this Honourable Court, did dishonestly induce one Mustapha Bala to deliver to you the sum of **₦1,100,000.00 (One Million, One Hundred Thousand Naira only)** for the sale of Plot No. OW-29
