JUDGMENT

The charge against the defendant is dated 19th day of July, 2023 and filed 20th July, 2023 which reads as follows:

1. That you, **Suleiman Saheed Olayinka (a.k.a Amadan Suzan)**, sometime in May, 2023 or thereabouts, in Ilorin, Kwara State, within the jurisdiction of this Honourable Court, attempted to commit an offence of Cheating by Personation when you pretended and represented yourself to be one Amadan Suzan, a white lady with Gmail account amadansuzan67@gmail.com to one Victor Krause II, and thereby committed an offence contrary to and punishable under Section 95 of the Penal Code Laws of Northern Nigeria.

The defendant pleaded guilty to the charge.

The Prosecution thereafter reviewed the facts of the case and tendered the following items in evidence:

1. One EFCC ownership Attestation form in the name of **Suleiman Saheed Olayinka** - Exhibit 1
2. One phone identified as Samsung A3 - Exhibit 2
3. Computer generated documents together with a certificate of identification - Exhibit 3A & 3B
4. Two statements of **Suleiman Saheed Olayinka** dated 10/5/23 & 26/5/23 - Exhibits 4A & 4B.

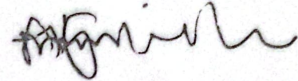
Pursuant to the guilty plea of the defendant, the facts reviewed by the prosecution and the evidence before the court, the court is satisfied that

the offence in issue is proved beyond reasonable doubt against the defendant.

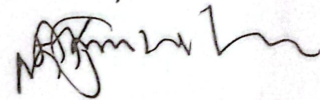

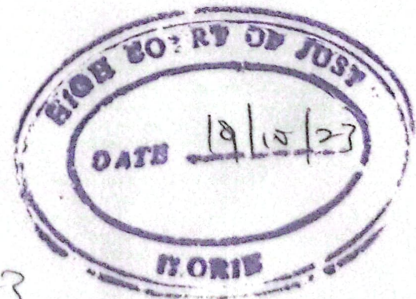
