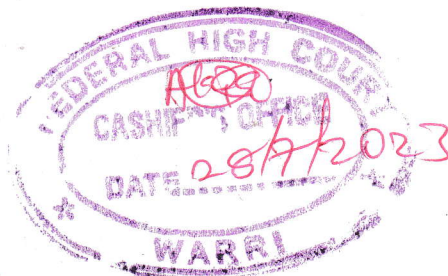
J U D G M E N T

Consequently:-

1. The defendant is sentenced to four (4) months imprisonment commencing from the date of his arrest which is 20/8/2019 and a fine of N200,000.00 (Two hundred thousand Naira) only.
2. The defendant shall forfeit to the Federal Government of Nigeria the following items which he disclosed are proceeds of crime:
 - (a) HP Laptop;
 - (b) iPhone 6 Max.
3. The forfeiture of the above assets shall not operate as a foreclosure against the commission from applying to the Court for forfeiture of any other asset subsequently traced to defendant as proceeds of crime with which he is charged.

4. The defendant shall undertake in writing to be of good behavior and law abiding.

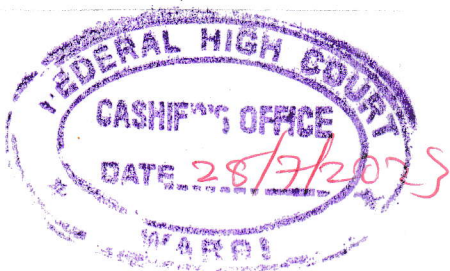
