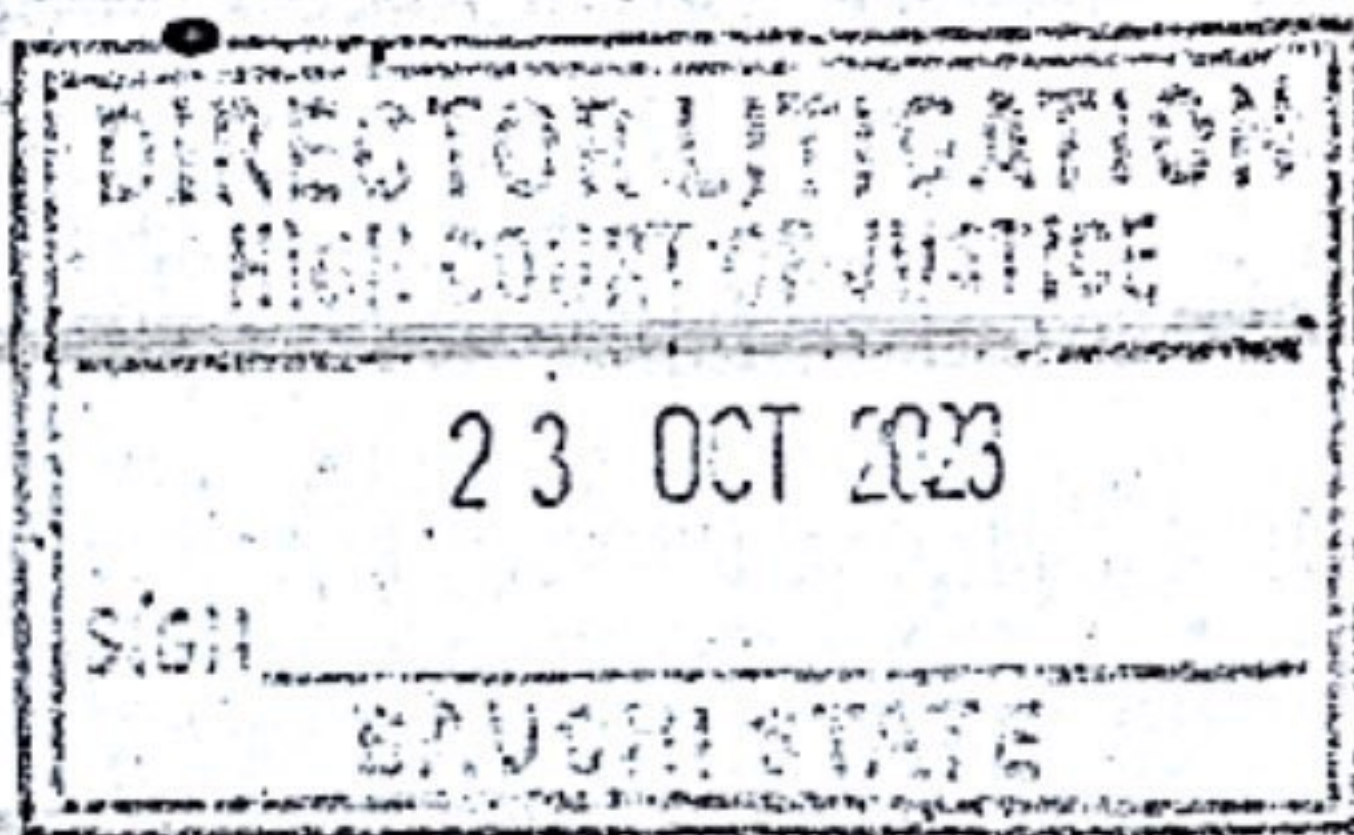
THE CHARGE

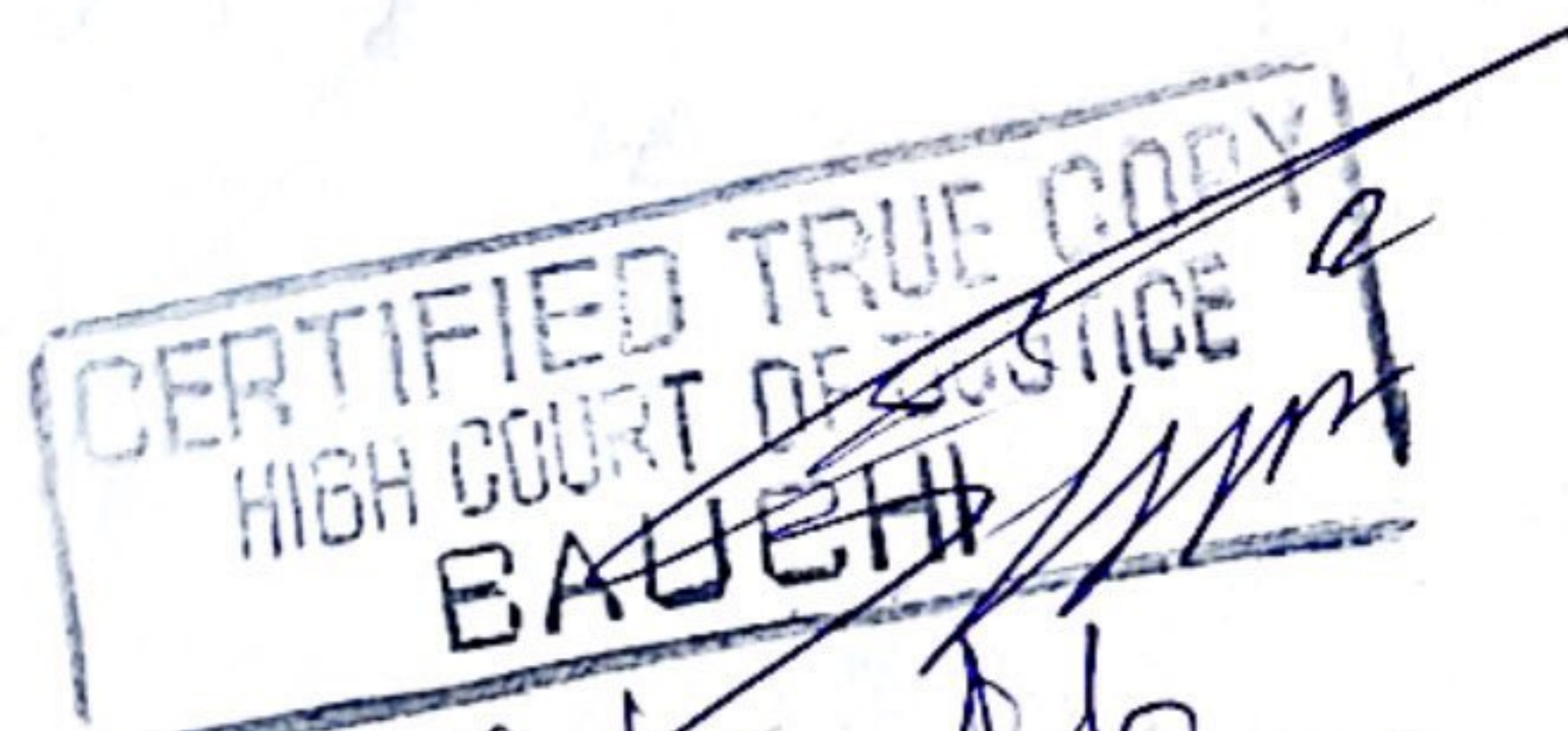
ZACHIOUS- We pray for the liberal sentence of the defendant, for being a young boy of 20 years and also a student.
