opposing.

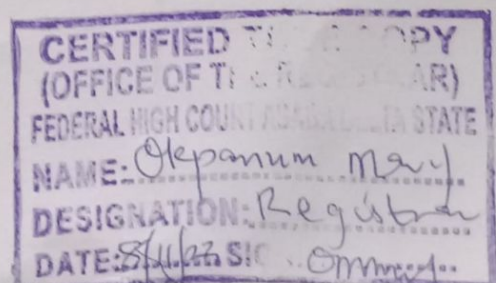

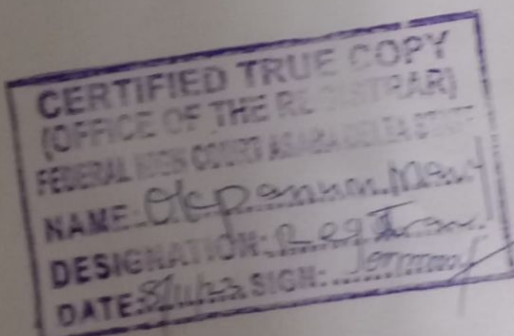

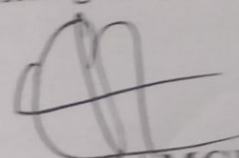


IT IS HEREBY ORDERED AS FOLLOWS:

1. Defendant is found GUILTY as Charged.
2. He is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correctional Service (NCS) or option of ₦200,000.00 (Two Hundred Thousand Naira) fine payable into the account which fines levied by this Court are paid. Sentence to commence from today.
3. That the Convict shall forfeit one ash with IMEI Number: 359238068279804 and one milk colour iphone x Max with IMEI Number: 357262095580069 recovered from him as instrumentalities of crime with which he is convicted to the Federal Government of Nigeria through Economic and Financial Crimes Commission (EFCC).
4. That Nothing shall preclude the prosecution from proceeding to attach and forfeit to the Federal Government of Nigeria any property that may be traced to the Convict as having been purchased with proceeds of the crime with which he is herein convicted.
5. That convict shall make undertaking to be of good behaviour and that he will never be involved in committing internet fraud or any offences again.
