COURT: Charge dated 4th October, 2022 is struck out and substituted with amended charge dated 25th, October, 2022.

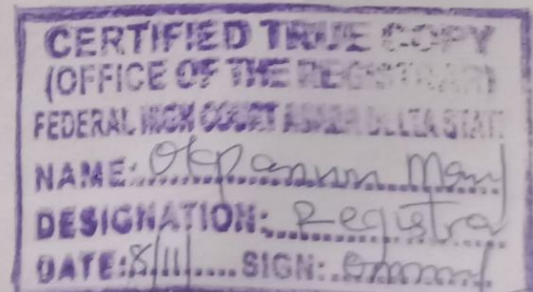
*Defendant in dock, unfettered*

DEFENDANT:

PROSECUTING COUNSEL: In view of the plea of the defendant, may we refer commend to the Honourable Court a plea bargain agreement between the prosecutor and the defendant. Pursuant to Section 270 and 356 subsection 2 of the ACJA 2015, I urge the court to accept the plea bargain as the judgment of this court, convict and sentence the defendant accordingly

DEFENDANT COUNSEL: We are aware of the plea bargain. The defendant pleaded guilty in line with the plea bargain agreement and legal advise given to him. We urge the court to adopt the plea bargain as the judgment of the court

COURT: Defendant having pleaded guilty to the essential elements of the offense stated on the amended charge and his counsel having indicated that the plea bargain agreement dated 25th October, 2022 filed on 26th October, 2022 was voluntarily entered into, the court hereby delivered judgment as follows: Defendant is guilty as charged. He is sentenced to 3 years in the custody of the Nigeria Correctional Service or option of fine of 200,000 Naira. Sentence to commence from today. The plea bargain agreement is hereby made the judgment of this court
