The Defendant having pleaded GUILTY to the Charge.

AND AFTER HEARING *I.K. Agwai Esq* for the prosecution applying that the Plea Bargain Agreement dated 25th October, 2022 but filed 26th October, 2022 be made the Judgment of the Court.
AND *O. Osasuwa Esq* for the Defendant not opposing.





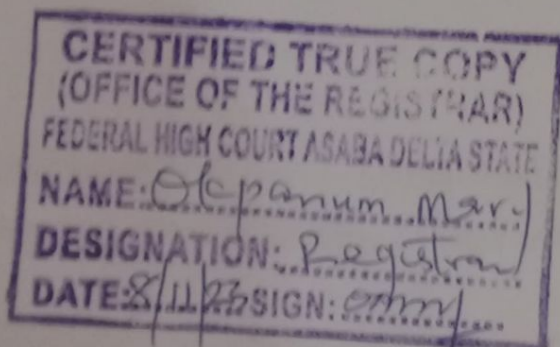

IT IS HEREBY ORDERED AS FOLLOWS:

1. Defendant is found **GUILTY** as Charged.
2. He is sentenced to 3 (Three) Years Imprisonment in the custody of the Nigerian Correction Service (NCS) or option of ₦200,000.00 (Two Hundred Thousand Naira) fine payable into the account which fines levied by this Court are paid. Sentence to commence from today.
3. That the Convict shall forfeit to the Federal Government of Nigeria One iphone 7plus with IMEI Number 35915107106831 and Hisense mobile phone with IMEI Number 860193048130472 as instrumentalities of crime recovered in the course of investigation through Economic and Financial Crimes Commission (EFCC).
4. That convict shall make undertaking to be of good behavior and that he will never be involved in committing internet fraud or any offences again.
5. That Nothing shall preclude the prosecution from proceeding to attach and forfeit to the Federal Government of Nigeria any property that may be traced to the Convict as having been purchased with proceeds of the crime with which he is herein convicted.
