## **JUDGMENT**

The Defendant has pleaded guilty to the essential elements of the offence of fraudulently impersonating other persons with intent to gain advantage contrary to and punishable under Section 22(2)(b) of the Cybercrimes (Prohibition and Prevention) Act 2015.

The facts of the case have been presented by the Prosecution and Exhibits P1 to P7 have been tendered without objection from the

## Allocutus:

Defence Counsel: As contained in the plea bargain agreement, convict co-operated with the prosecution. He is sober and is ready to channel his energy towards nation building. Is remorseful. Court should temper justice with mercy.

## SENTENCE

Convict is sentenced in accordance with the plea bargain agreement dated 25<sup>th</sup> October, 2021 filed on 29<sup>th</sup> October, 2021 as follows:

A term of 3 years imprisonment in the custody of the Nigerian Correctional Service with option of N200,000.00 (Two Hundred Thousand Naira) fine payable into the account in which fines

levied by this Court are paid.

It is further ordered that convict shall forfeit his Black I phone 12 and contents of his Access Bank Account No: 1404195273 to the Federal Government of Nigeria through the Economic and Financial Crimes Commission (EFCC).

In the event that the need arises to do so in future, the Economic and Financial Crimes Commission (EFCC) may apply to the Court for the forfeiture of any other assets traced to the Convict as proceeds of the crime stated in the charge dated 25<sup>th</sup> October, 2021.
