#### **JUDGMENT**

1. The defendant was arraigned before this court on or two count charge alleging as follows:

#### COUNT 1

That you **EZUKUSE KINGSLEY SOMTO** sometime in July 2020 to June 2021 in Ilorin, Kwara State within the jurisdiction of this Honourable Court did knowingly have under your control Two Million Three Hundred Thousand one Hundred and Eighty Naira (N2,300,180) paid into your Guaranty Trust Bank Account No. 0171721002 which is reasonably suspected to be unlawfully obtained and thereby committed an offence contrary to section 319A of the Penal Code and punishable under the same law.

#### COUNT 2

That you, **EZUKUSE KINGSLEY SOMTO** on or about August 2021 to September 2021 in Ilorin, Kwara State within the jurisdiction of this Honourable Court did cheat by personation when you pretended to be one **Swole Bear Scott** a Military Officer and fraudulently induced one **Nathaniel Schnabel** to part with \$500 and thereby committed an offence

contrary section 321 of the Penal Code and punishable under section 324 of the same law.

- 2. Testifying for the prosecution after the plea of the defendant was taken, Det. Kamaldeen yahaya stated that following Intel received by his commission on the activities of suspected internet fraudsters operating around Malete, Kwara State, operatives from the EFCC raided the area where upon the defendant was arrested amongst others.
  - It is the evidence of PW1 that on analysing the IPhone II Promax found with the defendant fraudulently induced Nathaniel Schnabel to send him \$500.
  - 3. It is also the evidence of PW1 that the defendant had in his Gtbank account the sum of №2, 300,180 between July 2020 and June 2021 money suspected to be proceeds of his unlawful activity.
    - Pw1 stated that the defendant confessed to committing the offence and has restituted in the sun of \$550 and ₹261,000.
    - In his address R.E. Akin urged the court to find as a fact that the prosecution has established the case against the defendant beyond reasonable doubt.
  - 4. The court is urged to convict the defendant on all counts.

    Mr. Salako had nothing to urge in favour of the defendant.

    I have considered the evidence of Pw1 and the defendant's guilty plea and hold that the prosecution has established the case against the defendant beyond reasonable doubt.
  - 5. I convict you **KINSLEY .E. SOMTO** of cheating by personation when you fraudulently induced Nathaniel to part with \$550 contrary to section 321 of the panel code law.

- 2. I also sentence you EZUKUSE KINSLEY SOMTO to a term of 6 months at Ilorin correctional center on count 2. Both sentences are to run concurrently and are hereby suspended under the supervision of Mr. Azeez of non custodian unit of Nigeria correctional services, Kwara State.
- 3. The IPhone II Pro max, the sum of \$550 and ₹261,000 are forfeited to Federal Government Nigeria.
