JUDGMENT

1. The defendant was arraigned before this court on a one count charge alleging that the defendant attempted to cheat Cathy Myers by pretending to be Mike Allen a white male contrary to section 95 of the penal code law.
2. The prosecution called Det. Ganiyat Ayoku as it only witness.
It is the evidence of Pw1 that following an anonymous petition received by her commission, operation raided Amoyo Area in the course of which the defendant was arrested.
It is the evidence of Pw1 that on analyzing the devices found with the defendant, it was discovered that he was involved in internet scam by representing himself as Mike Allen a white male and chatting with Cathy myers.
3. It is the further evidence of Pw1 that the defendant who did not profit from his engagement made statements to the


operatives of EFCC admitting to committing the offence alleged.
