COURT:

The defendant having pleaded to the essential element of the offense stated on the charge dated 7th January, 2022 but filed on 10th January, 2022, and its counsel having indicated that the defendant so pleaded upon his advice, Rasheed Buraimoh is found guilty as charged. There is also being an indication from the prosecution and defence that the plea bargain agreement dated 7th January, 2022 was voluntarily entered in to by the parties, convict is sentenced to 5 years in the custody of the Nigeria Correctional Service or option of 200,000 fine, to be paid into the account in which fines levied by this court are paid. Sentence shall commence from today. Orders of forfeiture, undertaking to be of good behavior and none foreclosure are also made in accordance with paragraph 3, 4, 5 and 6 of the said plea bargain agreement
