The Defendant having pleaded GUILTY to the Charge.


AND AFTER HEARING Ibrahim Mohammed Esq.

- He is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correctional Service (NCS) or option of fine of №200,000.00 (Two Hundred Thousand Naira) to be paid into the account in which fines levied by this Court are paid. Sentence shall commence from today.
- 3. This Court also makes orders of forfeiture, undertaking to be of good behavior and non fore-closure are also made in accordance with paragraphs 3, 4, 5 and 6 of the said Plea Bargain Agreement dated 7<sup>th</sup> January, 2022 but filed on 10<sup>th</sup> January, 2022, to wit:
  - (i) the convict shall forfeit to the Federal Government of Nigeria through Economic and Financial Crimes Commission (EFCC)
    - (a) One Samsung Galaxy S21 as instrument of crime recovered in the course of investigation.
    - (b) Toyota RAV4 with Registration Number ABJ 283 SC 2007 Model with Chassis Number JTMBO33V4 75070202 – Model as instrumentality of crime recovered in the course of investigation.
- 4. The convict shall make an undertaking in writing to be of good behavior and never get involved in committing internet fraud or any offences again.
- 5. This conviction and forfeiture of the above listed assets and properties shall not operate as a foreclosure against the Commission (EFCC) from applying to the Court for forfeiture of any other assets/property(ies) subsequently traced to the Convict as proceeds of crime with which he is charged and convicted not mentioned here.
