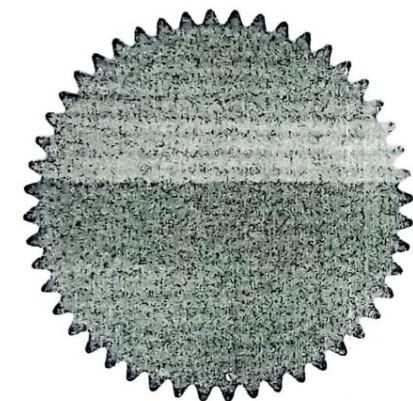

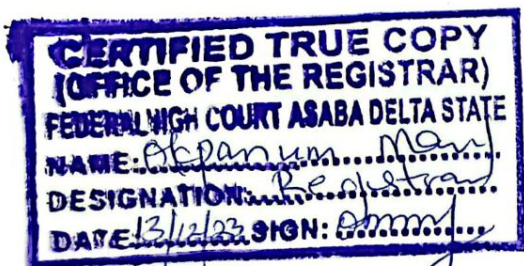
AND *O.L. Ogbelor Esq* for the Defendant not opposing.



IT IS HEREBY ORDERED AS FOLLOWS:

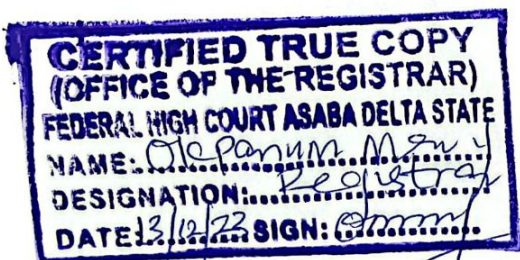
1. Defendant is found **GUILTY** as Charged.
2. He is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correctional Service (NCS) with option of ₦500,000.00 (Five Hundred Thousand Naira) fine payable into the account which fines levied by this Court are paid.
3. The Convict shall forfeit One Black coloured iphone X with IMEI Number; 354841092021509 to the Federal Government of Nigeria through Economic and Financial Crimes Commission (EFCC).
4. Paragraphs (4) and (5) of the Plea Bargain Agreement are also made the Judgment of this Court, to wit:



(i) The conviction of the Defendant and forfeiture of the above listed assets and properties shall not operate as a foreclosure against the Commission (EFCC) from applying to the Court for forfeiture of any other assets/property(ies) subsequently traced to the Defendant as proceeds of crime with which he is charged and convicted not mentioned here.

(ii) The convict shall make an undertaking in writing to be of good behavior.
