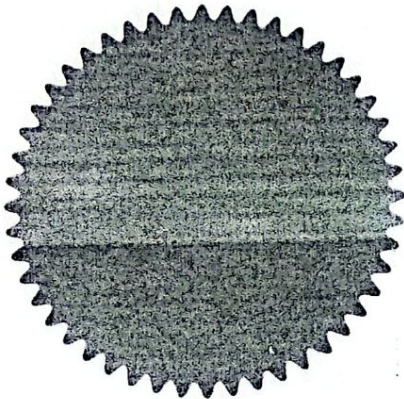
Count 1

That you **OSAGUNWERO RICHARD EHIGIE (M)** sometime between year 2020 and 12th September, 2021 at Benin City, Edo State within the jurisdiction of this Honourable Court with intent to defraud, sent electronic message which materially misrepresent your identity to **Shuk Wai Cheng**, a lady in the United States of America upon which she relied and suffered financial loss in the sum of \$19,000.00 and thereby committed an offence contrary to and punishable under Section 14(2) of the Cybercrime (Prohibition etc.) Act 2015.

The Defendant having pleaded GUILTY to the Charge.

AND AFTER HEARING *Francis .A. Jirbo Esq* with *K.Y. Bello Esq* for the prosecution applying that the Plea Bargain Agreement dated 18th November, 2021 but filed 19th November, 2021 be made the Judgment of the Court.

IT IS HEREBY ORDERED AS FOLLOWS:

1. Defendant is found **GUILTY** as Charged.
2. He is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correction Service (NCS) with option of ₦1,000,000.00 (One Million Naira) fine payable into the account which fines levied by this Court are paid.
3. The Convict (OSAGUNWERO RICHARD EHIGIE) shall forfeit the sum of money in the Bank account stated at paragraph 5(iii)1 of the Plea Bargain Agreement and shall forfeit the items listed at paragraph 5(iii)2 thereof; to wit:
 - (a) Zenith Bank, Account Number: 22140443369
 - (b) UBA Plc, Account Number: 2185746731
 - (c) UBA Plc, Account Number: 2211852667
 - (d) One iphone 12 Pro Max with IMEI Number: 356725114711999.
 - (e) One iphone 7 Plus with IMEI Number: 359472084958988.
 - (f) One Ash coloured Apple Laptop.
 - (g) One Apple Wrist Watch Series Five
4. Paragraphs 5(iv)(a) of the Plea Bargain Agreement are also made the Judgment of this Court.
