UPON THIS AMENDED CHARGE dated 2<sup>nd</sup> September, 2022 but filed on 6<sup>th</sup> September, 2022.

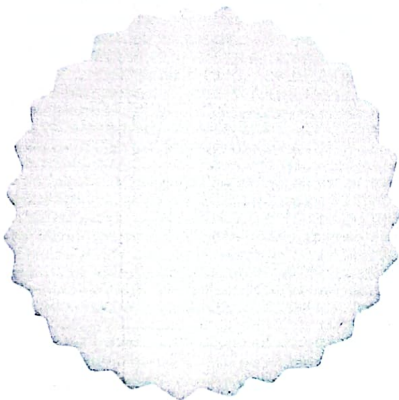
Count 1

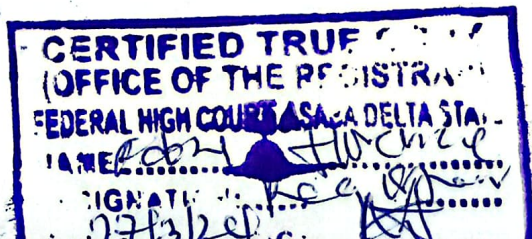
The Defendant having pleaded GUILTY to the Charge.

**IT IS HEREBY ORDERED AS FOLLOWS:**

1. Defendant is found **GUILTY** as Charged.
2. He is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correctional Service (NCS) or option of ₦300,000.00 (Three Hundred Thousand Naira) fine payable into the account which fines levied by this Court are paid. Sentence to commence from today.
3. That the Convict shall forfeit one iphone 12 Pro Max with IMEI NUMBER: 356723111395155 recovered from him as instrumentality of the crime with which he is convicted to the Federal Government of Nigeria through the Economic and Financial Crimes Commission (EFCC).
4. That Nothing shall preclude the prosecution from proceeding to attach and forfeit to the Federal Government of Nigeria any property that may be traced to the Convict as having been purchased with proceeds of the crime with which he is herein convicted.
5. That convict shall make undertaking to be of good behaviour and that he will never be involved in committing internet fraud or any offences again.
