The Defendant having pleaded GUILTY to the Charge.

AND AFTER HEARING Francis A. Jirbo Esq with *I.K. Agwai Esq* for the prosecution applying that the Plea Bargain Agreement dated 12th August, 2022 but filed 3rd November, 2022 be made the Judgment of the Court.

AND A.S. Akinfolarin Esq for the Defendant not opposing.

IT IS HEREBY ORDERED AS FOLLOWS:

- 1. Defendant is found GUILTY as Charged.
- 2. He is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correctional Service (NCS) or option of \$\frac{1}{2}300,000.00\$ (Three Hundred Thousand Naira) fine payable into the account which fines levied by this Court are paid. Sentence to commence from today.
- 3. That the Convict shall forfeit one iphone 11 pro with IMEI NUMBER: 357276091092788/358750487627711 recovered from him as instrumentality of the crime with which he is convicted to the Federal Government of Nigeria through the Economic and Financial Crimes Commission (EFCC).
- 4. That Nothing shall preclude the prosecution from proceeding to attach and forfeit to the Federal Government of Nigeria any property that may be traced to the Convict as having been purchased with proceeds of the crime with which he is herein convicted.
- 5. That convict shall make undertaking to be of good behaviour and that he will never be involved in committing internet fraud or any offences again.
