The Defendant having pleaded GUILTY to the Charge.

AND AFTER HEARING Francis A. Jirbo Esq for the prosecution applying that the Plea Bargain Agreement dated 21st July, 2022 but filed 26th July, 2022 be made the Judgment of the Court.

AND T.O. Obasuyi Esq for the Defendant not opposing.

IT IS HEREBY ORDERED AS FOLLOWS:

- 1. Defendant is found GUILTY as Charged.
- 2. He is sentenced to 5 (Five) Years Imprisonment in the custody of the Nigerian Correctional Service (NCS) or option of \$\frac{1}{2}300,000.00\$ (Three Hundred Thousand Naira) fine payable into the account which fines levied by this Court are paid. Sentence to commence from today.
- 3. That the Convict shall forfeit the balance of the sum of №925,982.55 (Nine Hundred and Twenty Five Thousand Nine Hundred and Eighty Two Naira, Fifty Five Kobo) in his First City Monument Bank Account Number: 7041876011 as proceeds of crime to the Federal Government of Nigeria through the Economic and Financial Crimes Commission (EFCC).
- 4. That the convict's First City Monument Bank Account Number: 7041876011 be permanently closed.
- 5. That the Convict shall forfeit one iphone 7 Plus with IMEI Number: 359176072998714 recovered from him as instrumentality of the crime with which he is convicted to the Federal Government of Nigeria through the Economic and Financial Crimes Commission (EFCC).
- 6. That Nothing shall preclude the prosecution from proceeding to attach and forfeit to the Federal Government of Nigeria any property that may be traced to the Convict as having been purchased with proceeds of the crime with which he is herein convicted.
- 7. That convict shall make undertaking to be of good behaviour and that he will never be involved in committing internet fraud or any offences again.
